Connacht Taekwon-do Schools Disciplinary Procedures

Young People

Breaches of the Code of Conduct fall into two categories – Good Practice and Child Protection. In general, the most common breaches tend to be that of good practice, i.e. lateness, disruption of the class, etc...

Procedures – For minor/moderate breaches, students will be given a verbal warning. Repeated breaches (or possibly on first occurrence of more serious type) may lead to being asked to leave the mats. Suspension or even expulsion may be utilized if the instructor deems it necessary for more serious infractions, e.g. bullying, inappropriate physical contact. Please note these procedures are in place to redirect the child from inappropriate behavior.

For breaches relating to Child Protection, the Child Protection Officer (CPO) or HSE contact will be informed, and advice sought.

Parents

Breaches of the Code of Conduct fall into two categories - Good Practice and Child Protection.

Procedures – For minor/moderate breaches of the Parents' Code of Conduct, the Parent will be politely reminded of his/her obligations, and asked to adhere to them. For successive breaches, the Parents' child may be removed from the class until such time as there is an undertaking from the parent to adhere to the Code of Conduct. The Child may be permanently expelled from the school if a Parent continually breaches the Code of Conduct.

For breaches relating to Child Protection, the Child Protection Officer (CPO) or HSE contact will be informed, and advice sought.

Adult Members

Breaches of the Code of Conduct fall into two categories – Good Practice and Child Protection.

Procedures – For minor/moderate breaches of the Adults' Code of Conduct, the member will be politely reminded of his/her obligations, and asked to adhere to them. For successive breaches, member may be removed from the class until such time as there is an undertaking to adhere to the Code of Conduct. The member may be permanently expelled from the school if a he/she continually breaches the Code of Conduct.

For breaches relating to Child Protection, the Child Protection Officer (CPO) or HSE contact will be informed, and advice sought.

Instructors

Breaches of the Code of Conduct fall into two categories – Good Practice and Child Protection. However in the case of instructors they may easily be interlinked.

Procedures – In the case of an instructor breaching Good Practice standards as laid down by Connacht Taekwon-do Schools, he/she will:

- (a) Be verbally warned to adhere to the Code of Good Practice in Children's Sport.
- (b) Be reported to the CPO and/or executive committee of the Irish United Taekwon-do Federation (IUTF)

For repeated breaches of Good Practice the instructor will be verbally and by letter advised to either adhere to the Code of Good Practice in Children's Sport or resign from teaching, lest they be reported to the HSE Children's Officer.

For breaches relating to Child Protection, the Child Protection Officer (CPO) or HSE contact will be informed, and advice sought.
